How to select a Legal Billing and Time Tracking Software

If you are still using paper notes, Excelsheets or your memory for tracking billable hours, you may be losing money and spending way too much time on your client billing

A software to help you manage

If you are a solo attorney (or CPA) or small firm you may not have an IT person to manage your servers. Selecting a Web-based system may free you up from managing, maintaining and upgrading desktop billing software

There are many choices in the market these days. Web-based legal billing systems do not require anything to be installed in-house.

Web-based legal invoicing
systems are generally
subscription based.

Subscription fees is generally based on number of users, number of clients, etc. A few (such as CaseFox.com) do not charge additional fees based on the number of users.

Select a system that offers role based user management so that you can control your staffs'/contract attorneys'/independent contractors' access to data

Check if the selected system can generate PDF and LEDES invoices and automatically email them to clients

Some Web-based systems provide many bells and whistles that you may never use. Go with a easy to use system with a cheaper subscription plan.

Remember, not all legal billing software include time tracking features. If it is a pure invoicing software, you will need to enter invoice line items manually for each invoice.

If you use contract attorneys, select a system that provides setting user permissions because you may not want contract attorneys to see your billing data and at the same time, you don't want to spend your own time entering time tracking data for your contract attorneys.

Also check if the selected system can export client, case and time tracking data to Excel format.

Most vendors provide a trial subscription. Try it before you commit. The most popular ones might not be fit for your specific needs or may not be easy to use.

Also, why would you pay \$30-50/month when you can get same features for \$10/month.
